Dear Ms. Negron:

As a valued donor, we are always eager to tell you that for every \$1 donated to the Greater Berks Food Bank (GBFB) we can acquire on average \$20 worth of food.

I have a wonderful example of how this works to share with you. Very recently, we had a trailer load of donated fresh cantaloupes and mini watermelons (25,000 pounds of watermelons and 15,000 pounds of cantaloupes) delivered from the Port of Camden, New Jersey. It cost the GBFB \$575 to have the melons transported from the Port to our Distribution Center. Based on current retail costs, the melons had a combined value of nearly \$31,000. So, based on what we paid for trucking, we actually brought in \$53 worth of fresh, healthy fruit for every \$1 spent! These melons were all distributed within one week. They supported three Produce 4 Kids distributions (nourishing about 2,000 elementary school children in the Reading School District); they were sent to several low-income elderly high-rises through our Mobile Direct Program; and supplied many local monthly food pantries. In total, thousands of local families were nourished by these healthy melons made possible because of donations such as yours. Thank you.

When you donate to the GBFB, your return on investment in our community is tremendous. We're also proud to let you know that 96.5 cents of every dollar donated goes to food and services.
